Backflow Prevention Programme: Received a letter from the City in late February that there is a new program to ensure dirty water does not infiltrate our clean water supply. Tourmangeau Engineering has surveyed the state of our current system and we have one device already and will need a second device installed by 2025. A test of the existing device is required by July 2023, and annually afterward. Once the new device is installed, a yearly inspection of our backflow systems is imposed by the City. More to follow from Wyn as estimates are received and our insurance company is contacted.
