## **Cashing of GICs**

- One GIC is the grant money for the door project, and since we anticipate that project being close to completion before the next GM, we are seeking approval to cash it at the upcoming GM. It has approximately \$26,000
- The other 2 GICs are also cashable GICs, and are needed so that we can pay for the Backflow device, the outstanding invoice for the website, and stipping and waxing of the floors. These two combined have approx \$25,000.
- The approximate total of all 4 items is \$27,000
- Backflow Prevention program is mandated by the city:
  - In May 2023, Tourmangeau Engineering indicated that there were 2 phases to the installation of the 2nd backflow device that we require. The design and permit phase, which is estimated to cost
- **Website invoice** still owing: \$3875, with a new hosting/maintenance/support invoice coming as of 1 June 2024 for approx \$1800
- Our **floors** badly need to be stripped and waxed upper and lower floors as the last time they were done was in 2020.
  - Stratus cleaners will do this work at a cost of 0.35/sq ft to strip and 0.15/sq ft per coat of wax. It is recommended that there be 3 coats of wax
  - Upper floor is 3876sq ft and requires a team to move the tables & chairs and pool/snooker/shuffleboard tables. \$1356.60 +HST for stripping; \$581.40 +HST/coat of wax for a total of approx \$3504
  - Lower floor is 2600sq ft \$910.00 +HST for stripping; \$390.00 +HST/wax coat for a total of approx \$2350
  - Total cost of approx \$6000

 We plan to start with the lower floor as it is glaringly obvious that the floor is in poor shape and it always looks dirty.

## **Fundraising**

- It should be apparent that we absolutely must do some fundraising if we are going to remain open for more than just a few more years. The fact that we have to resort to cashing GICs to pay for necessary work is a huge red flag.
- I really need help to find someone who has energy, initiative and enthusiasm to take on fundraising. It's the only way I can see to keep the Legion operating.
